Answer: Yes.

At balance date, 30 June 2023, Besra had entered into a contract note for US\$5m representing the 'Initial Deposit' of US\$2m, announced 4 April 2023, received from Quantum Metal Recovery Inc ("Quantum") in accordance with the non-binding term sheet for the US\$300m streaming facility (the "Facility") being settled, following which on 23 May 2023 Besra announced the receipt of a further US\$3m from Quantum representing the balance of the Initial Deposit. These funds were held in escrow pending shareholder approval. See also 3.7 above, costs incurred during the quarter in relation to the Facility (ie Gold Purchase Agreement).

At the Special Meeting of Shareholders held on July 24, 2023, the Gold Purchase Agreement, executed on May 9<sup>th</sup>, was approved. Following which Quantum settled the US\$5m Contract Note. A\$7.473k equivalent was paid to Besra on 25 July 2023. Use of these funds under point 8.7 above, allows for 5.5 quarters of funding.

In addition to the Initial Deposit, the Facility is scheduled to deliver US\$10m each month, commencing September 2023 for up to US\$300m. As such, the Company confidently believes it is able continue its operations and meet its business objectives.
